Edie Bogaczyk, Parent & Attorney A State Complaint is extremely important tool – it is a guaranteed legal right to Parents and Guardians of students with an IEP. It is a procedural protection, a procedural safeguard under the Individual with Disabilities Education ACT (IDEA). This session will explain when a State Complaint should be used, what it should include, what timelines are part of a State Complaint process, and examples of potential violations.

While sharing their home, the provider integrates the person served into the life of the household and the greater community. You will learn from the different perspectives of each person involved, understand how host homes work, and be provided with the knowledge you need to further explore host homes for yourself and your family. ROOM C Health & Well-Being	Understanding Medical Trauma and the Importance of (Often Neglected) Emotional Healing Gayle Murray, Private Practice Psychotherapist; Compass Clinical Associates When children (and adults) have surgeries and other intrusive medical procedures, there can sometimes be emotional trauma related to those experiences. This is often difficult to identify and manage, especially if the individual was sedated and has limited or no clear "memories" of the causal event. Understanding how trauma is stored in our bodies gives us power to "listen" to the wisdom the symptoms are communicating and in turn to promote healing. When we are aware, we can then choose to move differently, increasing our resiliency and functioning.

Joan Baumert is a parent, grandparent, and guardian in addition to being a strong advocate for personalized services. She and her family became part of the Mosaic family many years ago when her son Ryan began receiving services from Mosaic. Joan has shared her and Ryan's story at events where she encouraged others to learn more about the opportunities within host homes and to "Just Do It." Joan feels the Mosaic Host Home program gives people with disabilities the opportunity to have the life they want, with guidance when needed. It provides them the ability to go and do, find belonging and connections within their communities, and allows them to be themselves.

Edie Bogaczyk has worked as an attorney for 20+ years and has been an advocate her entire adult life. After working in a variety of non-traditional legal roles, Edie returned to the practice of law working full time in an area of disability rights that would fulfill the need for legal support for families in special education law. Edie and her husband David have an adult son and daughter. Their son was born with Prader-Willi Syndrome and was a student with an IEP for 15 years. He graduated in May 2022.

Zachary Bogaczyk graduated in May 2022 earning his high school diploma after completing the Senior Plus program at Waukee High School. He always had a strong desire and motivation to work after completing high school and enjoyed a wide array of internships while honing his employment skills. Even though Zachary lives with Prader-Willi Syndrome, his unique challenges have not deterred him from pursuing his "dream" job in the community and he looks forward to sharing how important networking and self-advocacy is to forging his way into the employment sector.

Michelle Fron has worked with both children and adults with intellectual disabilities in various settings for 22 years. She began her career with Mosaic in September 2006 at a small agency in Fremont, NE. She transferred to the Des Moines agency in 2007. Michelle currently leads the Mosaic at Home Department at Mosaic of Central lowa. She loves the individualized support that the people being served receive in a host home setting. She has witnessed people flourish and live their best lives. What's more, Michelle enjoys seeing an individual who may not have had a family or strong natural supports of their own, become part of a family after transitioning into a host home. When Michelle isn't working, you will find her at any Buccaneers Hockey or ICubs game with her kids, or out on a bike trail. Michelle lives in Urbandale with her 3 children and their cockapoo, Topher.

Kristin Hanson is the CEO, Founder, and Clinical Director of Axis. She is a Board Certified Behavior Analyst credentialed through the Behavior Analyst Certification Board and a Licensed Behavior Analyst under the Iowa Board of Behavioral Science. She received her Bachelor's degree in Psychology from Grand View University, and her Master's degree in Child and Adolescent Psychology with a specialization in Applied Behavior Analysis from The Chicago School of Professional Psychology.

Mary Jankowski has been a licensed mental health counselor for 37 years, and in July of 2020 she opened Iowa's first cat café. Mary has a daughter who has disabilities and one of the goals of the business was to employ individuals with disabilities who might not otherwise have a chance to be a part of the work force. He has worked there for over 5 years as a dishwasher. Ryan is very social and loves to laugh with others. Some of his hobbies are playing in the miracle baseball league, going to camp, vacation/travel all over the country including 5+ trips to Florida/ Disney world, baseball games, football games and more. He also enjoys his privacy while working on his art. Ryan has a passion for his art work and loves to share it with others including giving away his finished pictures to co-workers and family. Ryan's outlook on life is a positive one. His positive attitude shines daily and is infectious to everyone he meets.

Gayle Murray has been providing child and family therapy for 28 years in the Des Moines area community. She has extensive clinical expertise in the area of childhood trauma that results from childhood sexual abuse, maltreatment, disruption and attachment struggles in families. Treating Medical Trauma is an area where she has grown and developed by learning from her clients as they work through their healing process together. Understanding the impact of Medical Trauma has been a natural outgrowth of working with other kinds of trauma in children. He later founded and supervises the award-winning Law and Policy in Action Clinic to give law students experience solving recurring, systemic problems that cannot be addressed through litigation. Over the past few years, the clinic teamed up with Disability Rights Iowa and private lawyers to overhaul the Iowa Department of Education rules about the use of seclusion and physical restraints in K-12 schools. They provide no -cost consultant services to nonprofits, community groups, governments, and businesses on disability, civil rights, housing healthcare, elder abuse, LGBTQ, and other issues. Len and his clinic students also represent and provide transactional services for families and present workshops on estate planning, guardianship, and other legal issues.

Curt Sills grew up Corning Iowa and graduated high school in 1990. He attended Southwestern Community College and holds a Bachelor degree in marketing from Iowa State University. Curt has worked for HyVee for 34 years holding practically every position at the store. In 2013, he moved into management of HyVee's emerging fuel station market beginning with a store in Waukee. Curt lives in Johnston and has one daughter who is a Freshman at Iowa State University. She is his pride and joy.

Bill Stumpf lives in Dubuque Iowa with his son Kyle. He is a graduate of Northeast Iowa Community College. Bill retired in 2021 after 15 years as a licensed practical nurse at an intermediate care facility for people with intellectual disabilities in Dubuque. Bill is also a member of the Dubuque County Disabilities Council. In 2019, Bill was the recipient of the Iowa Association of People Supporting Employment First (APSE) Advocacy Award and in 2020, he was the recipient of National APSE's Public Policy Award for his grassroots efforts supporting the employment first movement.

Kyle Stumpf is 33 years old and lives in Dubuque Iowa. He graduated from Dubuque Hempstead High School in 2009. After graduation he was employed in a sheltered work environment in a segregated setting at sub minimum wage. He worked in that setting for approximately four years. In 2014, he was hired at Papa John's Pizza in Dubuque. He has been employed there for eight years. He loves his job! He is making above minimum wage and has been saving money in his ABLE account for future independence and financial security. Kyle is a member of the Dubuque County Disabilities Council. He also has been a member of the Association of People Supporting Employment First (APSE). When he's not working, Kyle attends a Day Habilitation Program in Dubuque which allows him to volunteer at local organizations including the Public Library. Kyle enjoys live music, dancing, and swimming and loves to travel. In 2008, Kyle received the Hills and Dales Community Services Honor Award. He became active in Dubuque's Miracle League in 2021 and in 2022 was selected to represent the local league at the Miracle League National All-Star Series in Murfreesboro, Tennessee. In October 2019, Kyle participated in a legislative briefing in Washington D.C. to tell his story and advocate to end the practice of paying sub minimum wage for people with disabilities.
