

# The IEP process during COVID-19

Important facts for families and IEP teams during the health crisis

# **Virtual IEP Meetings**

During the pandemic, IEP meetings can be requested and held virtually or by phone. In person meetings may also occur if the members of the IEP team all agree to this option. Meeting notices are still required for virtual IEP meetings.

To effectively participate in a virtual IEP meeting, remember, as a parent you have the right to:

- Request a draft of the IEP prior to the meeting
- Audio record the meeting
- Invite someone to participate in the meeting
- Ask for Prior Written Notice documenting any proposed changes

## **Remote Learning and Related Services**

Guidance from the U.S. Department of Education and the Iowa Department of Education confirm the rights of students with disabilities to receive special education and related services as required under the Individuals with Disabilities Act (IDEA) during the COVID-19 pandemic.

During the COVID-19 Crisis, many districts in Iowa have allowed parents to choose the learning model that is best for their child and family. "We now go to the full concept of IDEA and the concepts of FAPE so we should be talking about three things: Access, Participation and Making progress. Those are the responsibilities of districts, of schools and of IEP teams."

Regardless of the learning setting IEP teams must provide a Free and Appropriate Public Education to students eligible under IDEA.

#### **Consent and Waiver Forms**

School districts can <u>not</u> require a parent to sign a waiver of child's rights to a Free and Appropriate Public Education in the Least Restrictive Environment during the COVID-19 Crisis.

## Services to Students: Page I of the IEP

During the COVID-19 Crisis, districts in Iowa have been directed to complete Page I of the IEP to document how supports and services from the IEP will be implemented for an individual receiving special education services in a remote or hybrid learning model. It is expected that page I will be completed by the annual review date or before, however, a parent may also request an IEP meeting to complete page I if it has not yet been done.

# Sample Additional Information Page (Page I) of the IEP

#### **Recovery Services**

In the state of Iowa, COVID-19 Recovery Services should be discussed as a possibility for eligible individuals.

- Recovery Services determined by an IEP/IFSP team should be designed to address skills and content that was not taught, as well as, the compounding effects of those skills not being taught due to closures related to COVID-19.
- It is important to note that Extended School Year Services are different from COVID-19 Recovery Services.
- Recovery services may be provided at any time up to one year after the end of the COVID-19 pandemic.

Recovery Services are to be provided in addition to supports and services identified in an eligible individual's IEP or IFSP.

The lowa Department of Education has made available to families and educators a collection of resources about educational services during this critical time.

This resource provides a visual chart explaining what should be considered when determining Recovery Services.
