Board membership requires the following commitments:

- A three-year board term. A maximum of four terms (total of 12 years) may be served.
- Typically, one in-person Board meeting and 3 virtual meetings. However, up to two in-person Board meetings per year (travel expenses paid) and up to four virtual Board meetings per year may occur. Virtual meetings are held in the evening on a weekday and generally last 2 hours or less. In-person meetings are held on weekends.
- Service on at least one Board Committee (monthly, hour-long conference calls).
- Work on Board and Committee business between meetings as needed.
- The general ability to respond to agency requests by phone and/or email within 24 hours.
- A financial donation that is significant for your situation. ASK does not set the contribution amount, but does require that 100% of the board membership donates to the organization. Board members give anywhere from \$5.00 to thousands of dollars depending on their situation.
